

### 3. Forms of attestation of higher education applicants

<b>Forms of attestation of applicants of higher education</b>	<p>Attestation of graduates of the educational program is carried out in the form of a public defense of the qualification work or a public demonstration of a creative project and an attestation exam and ends with the issuance of a document of the established model on awarding him with a master's degree with the assignment of qualifications: master of musical arts, teacher, artist of an orchestra (ensemble), conductor of a variety orchestra (ensemble).</p> <p>Attestation is carried out openly and publicly.</p>
<b>Requirements for qualifying work</b>	<p>The qualification work must contain the solution of a complex task or practical problem in the field of musical art, which involves conducting research and/or implementing innovations in pedagogy, performance, and is characterized by the uncertainty of conditions and requirements.</p> <p>The qualification work must not contain academic plagiarism, fabrication and falsification.</p> <p>The qualification work must be published before the defense on the official website of the higher education institution or in the electronic repository of the educational institution.</p>
<b>Requirements for certification examination</b>	<p>The attestation exam should assess the achievement of the learning outcomes defined by the standard and the educational program.</p>
<b>Requirements for public demonstration of a creative project</b>	<p>The public demonstration of the creative project is carried out in the form of performing a concert program and must demonstrate the ability to solve creative tasks related to the performance of musical works.</p>


## 6. System of internal quality assurance of higher education

Rivne State Humanitarian University operates a system of ensuring the quality of educational activities and the quality of higher education by the institution of higher education (system of internal quality assurance), which provides for the implementation of the following procedures and measures:

- 1) determination of the principles and procedures for ensuring the quality of higher education;
- 2) monitoring and periodic review of educational programs;
- 3) annual assessment of applicants for higher education, scientific and pedagogical staff of the institution of higher education and regular publication of the results of such assessments on the official website of the institution of higher education, on information stands and in any other way;
- 4) provision of advanced training of pedagogical, scientific and scientific-pedagogical workers;
- 5) ensuring the availability of the necessary resources for the organization of the educational process, including the independent work of higher education applicants for each educational program;
- 6) ensuring the availability of information systems for effective management of the educational process;
- 7) ensuring publicity of information about educational programs, degrees of higher education and qualifications;
- 8) ensuring compliance with academic integrity by employees of higher education institutions and students of higher education, including the creation and ensuring the functioning of an effective system for the prevention and detection of academic plagiarism;
- 9) in order to fulfill the tasks of the educational process of this standard for the organization of all kinds of individual, group and practical classes, the Rivne State Humanitarian University is provided with an instrumental fund, conditions for storage, maintenance and repair of musical instruments, a rehearsal base, fund libraries, specially equipped premises for concert events, educational orchestras, ensembles, choirs, bases of pedagogical, performance and other types of practice and resources for the organization of events related to musical performance, research, lecturing, music-critical, concert activities, in accordance with the training programs of procedures and measures.

The system of ensuring the quality of educational activities and the quality of higher education by the institution of higher education (system of internal quality assurance) can be evaluated by the National Agency for Quality Assurance of Higher Education or independent institutions accredited by it for its compliance with the requirements of higher education quality assurance systems approved by the National Agency for Higher Education Quality Assurance and international standards and recommendations for higher education quality assurance.
