3. Forms of certification of applicants for higher education

The attestation of higher education applicants for the Master's degree in Psychology, specialty 053 Psychology is carried out in the form of defense (demonstration) of the qualification work and attestation exam in the specialty. The attestation is carried out in

public.

Qualification work involves the independent solution of a complex task or a complex problem in the field of psychology, which is accompanied by research and/or the use of innovative approaches and characterized by the uncertainty of conditions and requirements. There can be no academic plagiarism, fabrication or falsification in the qualification work. The qualification work must be posted on the website of the institution of higher education or its structural unit, or in the repository of the institution of higher education.

The attestation exam in the specialty is conducted at an open meeting of the examination commission with the participation of at least half of the commission members with the obligatory presence of the chairman of the commission in oral form and consists of testing theoretical knowledge and practical skills. The attestation exam provides the assessment of mandatory learning outcomes determined by this educational program.

The attestation ends with the issuance of a document of the prescribed format on awarding the graduate with a Master's degree with the qualification "Master of Psychology. Lecturer of psychology. Psychologist".
